To apply that failed logic would, for example, make it impossible to prove that a crime occurred, that a plane fell from the sky if it wasn't seen crashing (the pieces, the skeptics would, say were put on the ground that way), etc.

While I do think that it is reasonable to require someone who claims to have the ability to perform a "paranormal" feat to do so under controlled conditions, it is not reasonable to demand that events, which qualify as paranormal, be repeated for the benefit of anyone when sufficient evidence, the aforementioned "best available evidence", already exists in abundance.

All that really is required is the *qualified, expert* examination of that evidence to determine its authenticity. However, should groups with vested interests, such as the professional skeptics, still equivocate, then it is certainly fair and necessary to demand that they duplicate the evidence in every aspect and detail, as I have demanded of them, a challenge they accepted but failed to meet.

"Any fair-minded and reasonable person will agree that the Meier case has already met and exceeded the criteria for meeting the term "paranormal", i.e. "unable to be explained in terms of scientific knowledge" (see Marcel Vogel metal alloy analysis). A thing either is or isn't paranormal by definition and intellectual honesty requires that superimposing one's own arbitrary requirements for proof is, at the very least, unethical and also completely unscientific."
